USDA DESIGNATES 72 MICHIGAN COUNTIES AS PRIMARY NATURAL DISASTER AREAS

On July 2, 2012, the USDA announced the designation of 72 counties in Michigan as primary disaster areas due to damages and losses caused by severe weather in January 1 – May 11, 2012. These counties include:

USDA OFFICIALS TOUR MICHIGAN AND OTHER DROUGHT/ SEVERE WEATHER-AFFECTED STATES; USDA SECRETARIAL DISASTER DESIGNATION RULE AMENDED

On July 15, 2012, Under Secretary for Farm and Foreign Agricultural Services Michael Scuse began a tour of Michigan, Ohio, and Indiana—states affected by spring severe frosts and freezes and now increasing drought. Additional USDA subcabinet members will travel to Tennessee, Kentucky, Illinois, Arkansas, Missouri, Colorado, New Mexico, and Texas in the coming weeks. According to the USDA's press release, the purpose of the visits is to "show support to farmers and ranchers affected by a string of extreme weather in 2012." "USDA officials will also provide guidance on the department's existing disaster resources and remind producers to keep thorough records of losses. . . ."

On July 11, 2012, USDA Secretary Tom Vilsack announced "a package of program improvements that will deliver faster and more flexible assistance to farmers and ranchers devastated by natural disasters." The final rule for Secretarial disaster assistance will be amended to "nearly automatically" qualify a disaster county once it is categorized by the U.S. Drought Monitor as a severe drought for eight consecutive weeks during the growing season and streamline the Secretarial designation process.

NONCOMPETITION AGREEMENTS ARE ENFORCEABLE IF...

Noncompetition agreements typically prohibit an employee or seller of a business to own or work for a competitor of the protected party, and often are of substantial value. However, Michigan courts will only enforce these agreements if they comply with the following four requirements.

1. The agreement protects only "reasonable competitive business interests."

"Reasonable competitive business interests" include the protection of trade secrets, confidential information, and relationships with customers and suppliers. A noncompetition agreement may not be used to prohibit a person's ability to use general knowledge or skills.

2. The agreement is of reasonable duration.

There is no litmus test for whether the agreement is reasonable in duration, since the reasonableness of the duration depends upon the business interests being protected. Durations of one or two years are generally found to be reasonable, although longer periods have been upheld in connection with the sale of a business.

3. The agreement is reasonable in geographic scope.

The agreement's geographic scope should generally be limited to the area in which the protected party does business or will do business, including the area from which the business's clients are drawn. A good test is to consider whether competition at each restricted location could reasonably have an adverse impact on the protected party.

4. The agreement is reasonable in the type of activity restrained.

The restriction should be broad enough to protect only the protected party's legitimate business interests, such as by only prohibiting the restricted party from competing in the protected party's field, and should not unduly impair the restricted party's ability to earn a living in other fields.

In light of the above, it is important that noncompetition agreements be reasonable and carefully drafted to ensure that the agreement is enforceable.

MICHIGAN AGRICULTURAL DISASTER LOAN ORIGINATION PROGRAM ACT OF 2012 SIGNED INTO LAW

On June 26, 2012, Governor Snyder signed the Agricultural Disaster Loan Origination Program Act of 2012 into law. The law requires a one-time \$15-million appropriation to cover some costs for banks that offer agricultural loans to farmers and processors affected by the severe weather this spring. "This is the worst natural disaster to strike Michigan's agricultural industry in more than 50 years," Governor Snyder

said. "Agriculture is a key component of our economy, and these loans will help keep our fruit farmers afloat until next season," said Snyder.
